

# Privacy Policy

This Privacy Policy governs the manner in which Meredox Ltd collects, uses, maintains and discloses information collected from users (each, a "User") of the www.schoolsoftware.com.ng website ("Site"). This privacy policy applies to the Site and all products and services offered by Meredox Ltd.

## Personal identification information
